#### Accommodation

i. In London: The Participants are requested to arrange their accommodation in London through Indian High Commission. For this a copy of sanction letter has to be forwarded to Indian High Commission requesting them to book the Hotel as well as provide all the courtesies viz. Pick up and Drop service at Heathrow Airport.

#### **Travel Arrangement**

Domestic & International: The participant will have to arrange for their domestic travel and local conveyance for attending training programme in New Delhi; The Participant has to also arrange his/her own return air tickets for travelling to London as per entitlements and apply for visa and Political Clearance immediately after nomination. The Local conveyance to reach the Training Place and back to the Hotel in London will also be the responsibility of the participants.

#### **Cancellation Policy**

Cancellation can be done 30 days before the start of the course for full refund. If the cancellation is done between 30 days and 15 days before the start of the course, then 50 % of the fees will be refunded. If the cancellation is done within 15 days of the start of the course, no fee will be refunded.
