# INTERNATIONAL MANAGEMENT COURSE ON SEA TRANSPORTATION AND LOGISTICS

(LONDON)

Duration: 7 Days (February 9-15, 2020)

**Course Fees:** 2,90,000 + 18% GST

#### Fees include the following:

- 1. Visa application assistance and fees (the participant will be required to go for bio-metric appointment to VFS);
- 2. Transfer from the Airport to the Hotel and from Hotel to the Airport in London;
- 3. Complimentary Metro and Bus (Oyster) card for local travel in London during the entire stay;
- 4. Four star single occupancy hotel accommodation in the U.K. for 6 nights with breakfast;
- 5. Course training fee for the U.K.

#### Nomination and fees transfer must be completed by December 31, 2019.

**Note:** Kindly strictly adhere to the time schedule as we are required to transfer funds to our counterpart in London at least 30 days in advance, also while booking the hotels full payment has to be made in advance.

# **COURSE GUIDELINES**

#### **Batch Size**

Nominations of a minimum of 10 delegates is necessary to form a dedicated batch for the customised course.

#### **Accommodation**

In the U.K.: The accommodation (single occupancy) for 6 nights with breakfast will be arranged by PARI and DODS in the U.K.

# **Travel Arrangement**

**International:** The participants will have to arrange for Delhi-London-Delhi ticket as per their entitlements. PARI will apply for visa immediately after nomination is received with fees and will also bear the visa costs. In London, the participants will be received at the Airport and seen off by a representative of the PARI/DODS.

**National:** The participants will have to arrange travel to and within Delhi and local accommodation on their own.

# Passport/DA/Political Clearance

Personal Passport (Blue) will be required for visa application. You are requested to draw DA from your office as per the rules. Political clearance is not required, if you are travelling on personal passport.

# **Cancellation Policy**

Cancellation can be done 30 days before the start of the course @ 20% deduction. If the cancellation is done between 30 days and 15 days before the start of the course, then 50% of the fees will be refunded. If the cancellation is done within 15 days of the start of the course, no fee will be refunded.

**NOTE:** Kindly transfer Fees along with nomination. A nomination without Fees will not be considered valid.

#### **ABOUT THE COURSE**

Sea transportation is a vital means of transport for the prosperity of a country. It has an impact on the rate of development. It is the most optimal cost efficient means of transporting a large number of goods and creates employment opportunity in other dependant industries like shipbuilding, ship breaking, ship repairing, maritime training etc. It plays a huge role in increasing trade.

Sea transportation services in India have made tremendous progress over the years and the scenario for Sea transport has changed after liberalization. It became very competitive be it for cargo or for mobilizing resources. Policy changes like moderation of the Cabotage law and cargo reservation policy meant International ships decking at Indian ports did not require a license.

Also the volume of cargo handled and container traffic in the major ports has increased from 152.6 million tons in 1990-91 to 519.1 million tons in 2007-08 in India maritime transport. (Source: http://www.tradechakra.com/indian-economy/infrastructure/maritime-transport.html)
