Brief Scientific Report

The 7th National Conference of World Association for Psychosocial Rehabilitation-Indian Chapter was organized by LGBRIMH, Tezpur and WAPR-IC on 17th and 18th of March, 2023. The conference consisted of speakers from across the globe with carefully selected array of topics relevant to the theme. The conference was supported by North Eastern Council, Government of India, Shillong, Mariwala Health Foundation, Mumbai, Indian Overseas Bank Tezpur, CPWD, Tezpur, Sigma Technologies, Bengaluru, Parliamentary Administrative Research Institute (PARI Training), New Delhi. INTAS Pharmaceuticals, Rusan Pharmaceuticals, Linux Laboratories Pvt. Ltd., Oxpro Pharma Pvt. Ltd., Life Supports and Pharmaceuticals, Sun Pharma, Alteus Biogenics, Shine **Pharmaceuticals** Ltd., Bokahola Tea Co. Pvt. Ltd, **Jorhat** 785001 (bokaholasales@gmail.com).

A total of 256 delegates participated in the conference from different part of the country. To deliver evidence based and well-informed scientific sessions, 35 eminent experts from the field of mental health (psychiatrists, clinical psychologists, psychiatric social workers, NGO personnel) were called from India and abroad. The list of speakers also included persons with lived experiences and caregivers with the objective of highlighting the issues and needs of service users and to strengthen the existing psychosocial and rehabilitation-oriented service delivery models.

Dr. Karuna Hazarika, Principal, Tezpur Medical College and Dr. Bharat Vatwani, Founder of Shraddha Rehabilitation Foundation and Magsaysay award winner were the Chief Guest and Guest of Honour respectively for the inaugural function on 17th of March 2023. Dr. Gabriele

Rocca, President WAPR, Dr. Radhakrishnan, Secretary General, WAPR, Dr. Murali Thyloth Immediate Past President WAPR, Dr. C. Ramasubramanian President WAPR-IC, Dr. H Chandrashekar Secretary WAPR-IC addressed the gathering. Dr. S.K Deuri Director and Organising Chairperson welcomed the delegates and Dr. Sobhana H Organising Secretary gave the vote of thanks.

The Valedictory function was held on the 18th March 2023. Dr. Mathew Varghese, Vice President of WAPR-IC presided over the meeting. Dr. H Chandrashekar Secretary WAPR-IC was also present on the dais. Dr. Sonia P Deuri, Chairperson Publicity and PR Committee, Head of Department of Psychiatric Social Work gave the welcome address, Dr. P Abhishek, Chairperson Scientific Committee read out the conference report. Dr. S.K Deuri addressed the delegates. Four delegates also gave feedback on the conference. Dr. Sobhana H gave the vote of thanks.

The scientific programme included two plenary sessions, six workshops, two corporate sessions and a panel discussion. Researchers working in the area of psychosocial rehabilitation for persons with mental illness participated in significant number and a total of 66 free papers were presented during the technical sessions.

Plenary 1: Theme-Promoting Rights and Recovery in Mental Health *Speakers:*

Dr. Gabriele Rocca- Speaking on the topic **Deinstitutionalization and Human Rights:A critical issue,** Dr. Rocca presented the historical perspective of deinstitutionalization and highlighted the fundamental questions such as pathophysiology and psychiatric symptoms, molecular processes, and psychiatric disorders. He also emphasized on innovation in deinstitutionalization, need for community-based practices, many crucial aspects on a rights-based approach in the development of mental health services.

Dr. V. K. Radhakrishanan: In his talk, Dr. V.K. Radhakrishnan spoke about the **Genesis** and **Importance of World Association for Psychosocial Rehabilitation**. He also described how the first world congress on Rehabilitation of Mentally III in Helsinki, in 1970 paved the path for the planning of the association which was formed in 1986 in Lyon France, with Dr. Oliver Wilson as its first president.

Dr. Murali Thyloth: The topic by Dr. Murali Thyloth was **Rights Training Module**. He described the recent NHRC 2023 findings on the present status of mental health care institutions. He pointed out that despite the enactment of MHCA 2017, there are instances of individuals with severe mental illness kept chained, and abandoned by the family. He also discussed in length the important factors in psychosocial rehabilitation.

Dr. Alexander Smith: Rights and Recovery in Psychosocial Rehabilitation Services in the US was the title of the talk by Dr. Alexander Smith. He shared his experiences with the practice and system change with community mental health services in Vermont USA. Some current areas of focus regarding rights and recovery in psychosocial rehabilitation in the US which include trauma informed services. He highlighted the importance and application of Open Dialogue (Collaborative Network Approach) in psychosocial rehabilitation in Addison County and described the challenges with right based practices in the US.

Plenary 2: In Memoriam: Prof M. Sarada Menon- A Legacy in Psychosocial Rehabilitation

The 2nd Plenary session was a Memoriam on Prof. M Sarada Menon the first woman psychiatrist and the founder of Schizophrenia Research Foundation (SCARF). She highlighted the immense contribution by Dr. Sharada Menon to the field of mental health and psychosocial rehabilitation. Dr. Thara recalled Dr. Menon as a caring and committed professional who considered the involvement of the family to be cardinal to the recovery and rehabilitation. Dr. Menon was instrumental in founding the Indian Chapter of WAPR.

All speakers highlighted the importance of participation of stakeholders such as users, caregivers, communities, religious & political heads, and legal authorities as the reason behind the success of the models of psychosocial rehabilitation. The advantages of bringing in peer support volunteers and motivated local volunteers were emphasized. Despite the struggles faced with limited resources & manpower, all the models provide an example & give hope for community based psychosocial rehabilitation in India that is culturally sensitive which follows a Rights Based Approach.

Speakers discussed the status of psychosocial rehabilitation in Assam from the collective, contextual and community perspectives by emphasizing the need for harnessing the traditional ethnic and religious practices of the various communities in Assam. Further, the need for community-based rehabilitation, about the challenges in delivering mental healthcare services in India, including lack of adequate funds and lack of mental health personnel were highlighted. The session also focused on the feasibility, safety and outcome of persons with opioid dependence in non-custodial and collaborative facility in Assam and Arunachal Pradesh.

The session highlighted the facets and facts of the Mental Health Care Act, 2017 and some of the challenges in its implementation. The act was discussed in the context of rehabilitation of homeless persons with mental illness and in the process the Chittaprakasha Charitable Trust experiences were shared. The role of statutory bodies in rehabilitation of persons with mental illness was also discussed. An overview of Rights of Persons with Disability Act, and its implications in the care of persons with severe mental illness was also discussed.

The session primarily highlighted the need for the inclusion of family in the treatment of persons with mental illness. Crucial facets of family interventions, such as role of family in psychoses, tasks in intervention, effective problem solving, managing crisis and several such important aspects were emphasized. Further evidenced based family interventions were a major focus of the session. Further highlights of the session were implication of family intervention in schizophrenia, predictors of burden for caregivers, Yoga and psychosocial programme for caregivers, and the need for family centric rehabilitation for persons with

mental illness. The session also elaborated upon the home-based rehabilitation model and family caregiver intervention and support programme in dementia.

Symposium-6- The Role of Work in Recovery, Restitution and Rehabilitation of the

Persons with Mental Illness: A Historical Account of the Asylums of India

The session started with a description of the 19th century Victorian England practices of occupational therapy and the then prevailing concepts of work therapy and Pinel's contribution, development of the emancipatory and integrative approaches in psychiatry from 1800-1950. It further highlighted the system of work in Asylums of Bengal, the Lunatic Asylum, Bangalore, costs of providing employment and the regional differences in India a the end of 19th century. The issue of work in asylum as therapy vs colonial exploitation was also emphasized. A major focus of the session was the therapeutic and rehabilitative functions of employment, and how simple work engagement can be stimulating to persons with mental illness. The session further highlighted the narratives of institutionalization and de-institutionalization are basically the narratives of power. Efforts of care in integrations in Ranchi mental hospitals was presented. Finally, the journey of LGBRIMH, from its establishment in 1876 to the construction of new budlings in 2018 was presented. The rehabilitation focussed approach of LGBRIMH, development of rehabilitative and future plans in the direction was elaborated upon.

Symposium 7: The Journey of Recovery Oriented Services (ROSes) café at NIMHANS:

Conceptualization, Current Status and Learnings

The experience of the ROSes café, its conceptualization, current status and the learning

which evolved in the rehabilitation of persons with mental illness was highlighted. The

symposium emphasised that the persons with severe mental illness (SMI) should be engaged

in domestic activities, and that a source of livelihood facilitates functional independence and

enhances self-esteem. ROSes café, an initiative towards facilitating employment for persons

with SMI proved to be a promising model which also augments the recovery process. Some

of the challenges identified in the model were recruiting and managing the flow of patients,

irregularity in attendance, and patients being unwilling to do certain tasks.

Symposium 8: Community Based Rehabilitation

The session elaborated upon the community based rehabilitation in the rural setting, and the

experiences gained of SCARF in Tamil Nadu, Jharkhand and Assam were shared. The STEP

program and its component were highlighted. Some of the major focus of the work in Tamil

Nadu toward the rehabilitation of mentally ill were training of community workers,

awareness programs, family empowerment. The Jharkhand and Assam experience also

highlighted the community led mental health programs including Tele Psychiatry, home visits

and counselling, support group meetings, and facilitating social contact. Experiences from the

two states support the CHIME framework for facilitating recovery.

Symposium 9: Mental Health of Immigrants and Refugees- Indian Scenario

Speakers explained the differences between refugee and migrant, and differentiated the

former also with foreigners. The refugee scenario in India was explained, and pertinent

statutory perspectives and policies were also highlighted. Further, a perspective was given on

the core human rights and their relation with refugee law, and how the Indian constitution

provides a basic framework that ensures the protection of refugees was highlighted. Finally,

the relation between migration and its possible effect on the development of psychiatric

disorders was explained.

Symposium 10: Integrating Knowledge and Methods of Neurosciences and

Psychotherapy for Recovery in Mental Illness

The session focussed on the neuropsychologically informed psychotherapy, and how such therapies help in the process of recovery for persons with mental illness. It highlighted the lasting effect of psychotherapy on measurable changes in the brain, formulation of neuroscience informed psychotherapy models, and the mediating/moderating role of psychotherapy in psychosocial recovery.

Symposium 11: Pragmatics of Running a Psychiatric Rehabilitation Work Program in India

The speakers explained that most rehabilitation included vocational activities that help in keeping patients involved, led to therapeutic skill training, generated income & improve QOL of patients. The session described the NIMHANS experience, where the vocational activities undertaken by persons with mental disorders met with the hospital requirements and also helped in producing saleable items.

Symposium 12: Social and Economic Inclusion of Persons with Mental Health Issues in India: Challenges and Gaps

The session cited the United Nations Sustainable goals to create sustainable world. The Rights of Persons with Disability Act, Mental Healthcare Act, and Rights to Property Act were also touched during the session citing their relevance in social and economic inclusion. Challenges and gaps in the process such as burden of cost of treatment, stigma, lack of awareness, poor budgetary allocation were also emphasized.

Symposium 13: Dementia-Friendly Hospitals: Insights for Implementation in the Indian Context

Dementia and the risk factors were highlighted. The gender and rural/urban distribution of the disease were also highlighted. Further, dementia care services, poor ratio of psychiatrists,

clinical psychologists, and psychiatric social workers in India were stressed upon. Finally, the

nuances in setting up dementia friendly hospitals were also discussed.

Symposium 14: Community-Based Services in the Field of Child and Adolescent Mental

The session introduced the parent child wellbeing clinic in NIMHANS, Bengaluru. The naure

of the clinic and its basic focus of dealing with minor emotiona/behavioural and relational

difficulties were highlighted. The holistic nature of interventions in the clinic such

assessments, parent-child interaction therapy, positive parenting practices and several other

practices were discussed. Further the session focussed on children in conflict with law and

the impact of the problem on the children in conflict with law (CCL), their families,

commuities and society in general. The need for reintegration and rehabiltation strategies for

CCL were also discussed.

The symposium highlighted the newer advancement of brain stimulation-based technology in

psychosocial rehabilitation. Some of the major highlights were the use transcranial direct

current stimulation and qEEG based neurofeedback in the stimulation and treatment of

persons with mental illness. In this context, research evidence and meta-analytical findings

were also presented.

The session focussed on the rehabilitative works at Paripurnata and Satra. The psychosocial

approach of intervention at these NGOs were discussed in detail. For example, how the

residents at Paripurnata are stimulated through socio-cultural activities like painting, signing,

dancing, participation in festivities etc. Satra also discussed their community based mental

health projects that focus on identification and facilitating treatment for persons with mental

illness in the community.

The panel discussants consisted of four caregivers among who two also were service users as

well. The discussants described the challenges of caregiving and the expectations they had for

from the government and mental health systems. This discussion seemed to be also cathartic

for the panellists where each one could explain their own experiences and relate to the

experiences of the others. It was suggested that mental health service delivery for persons

with chronic mental illness who are now aging needs to be strengthened. Caregivers also

spoke about the financial difficulties faced in providing regular treatment for their family

members. They emphasised on the need for support in the areas of livelihood, caregiving and

finance.

	evoked a lot of interest among the audience, and the current research in the field
	caught significant attention among the participants.
	The workshops provided opportunity enhance their competency in psychosocial
	rehabilitation services through the skills training sessions.
	The conference also provided an active platform to services users (persons with
